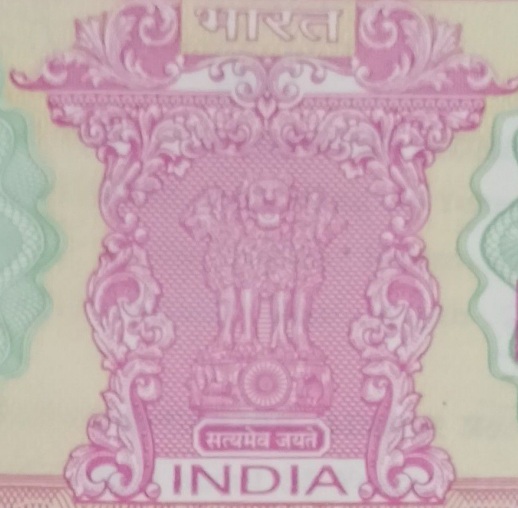

**All above Indian Citizen.**

**WHEREAS** the Settlor is desirous of creating an endowment by setting apart and establishing a fund in India for the object and purposes hereinafter expressed.

**AND WHEREAS** the trustees have at the request of the Settlor, agreed to act as trustees of these presents upon the terms and provisions hereinafter contained.

**HOW THIS INDENTURE WITNESSETH AS FOLLOWS :-**

In order to effectuate the said object of creating and establishing a Profitable charitable trust, the Settlor being absolutely seized and possessed of or otherwise well and sufficiently entitled to a sum of Rs.10,000/- (Rupees Ten Thousand Only), has delivered to and made over to the Trustees, the said sum of Rs. 10,000 (Rupees Ten Thousand only), with intent to part with all his right, title and interest and claim therein

and vest the same in the Trustees TO HAVE AND TO HOLD the same and the investment or investment for the time being representing the same and all other properties that may at the time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as "THE TRUST PROPERTY") for the objects and purposes and uses hereinafter expressed with the powers and other terms and conditions herein contained of and concerning the same.

The name of the trust shall be "**AT-TAUHEED CHARITABLE TRUST**" having its office, Vill-Bantra, PO-Bantra, PS-Bakultala, Dist- South 24 Parganas, Pin- 743337 West Bengal . Which may be shifted from time to time to such other place or place as the Trustees may deem fit and proper in their discretion.

#### **THE OBJECTS OF THE TRUST ARE:-**

To create fund and provide interest-free loans and assistance and Working with the persons with disabilities can be an extremely rewarding area of work which involves supporting disabled people to lead fuller, more independent lives, taking up education and employment opportunities and contributing to their communities. People who have mental or physical disabilities often face a unique set of challenges in their everyday life. The challenges individuals with disabilities face largely depends on their specific impairment as well as their severity.

To foster and encourage advancement of education, training, research and development in any branch/stream like general, medical, technical, etc, amongst other charitable activities to promote, establish, equip, set up, run, maintain and/or assist school, medical, technical and other colleges, universities

financial assistance to the institutions and/or individuals for any other activity for furtherance and dissemination of education - theoretical & applied.

To establish and maintain scholarships and/or aids to poor and/or meritorious students either by way of absolute gift or by providing educational loans upon such terms and conditions as the Trustees may deem fit and proper and refunding deposits to the entrepreneurs, business persons, self-help groups (SHGs) cultivators, students, depositors and general people with or without security under mutual terms and conditions agreed upon to facilitate the poor minorities and under-privileged people.

To collect donations, subscriptions, grants, deposits and service charges to create fund for the Trust and especially to run the SHGs Micro-Credit, Micro-Finance, CBOs, and Credit and Deposit Schemes of the Trust.

Establishing and maintaining and/or granting aid to schools, colleges, B.ED. College, hostels and Other institutions imparting education or maintaining facilities for research or Promoting the advancement of education.

Establishing and granting aid for promoting, supporting and/or maintaining Institutions for the promotion of science, computer literature, fine arts, diffusion Of useful knowledge, schools, colleges libraries, laboratories, research and other Similar institutions and societies.

Establishing and maintaining and/or granting aid to Hospitals Rotary Farm, Pigary Farm, Ayurvedic Research Centre, Nursing Homes and / or Institutions, Yogasan Centre, Upanishad and astrology research institute, Sanskrit college, Sanatoriums Travelling Dispensaries, After-care Clinics, Veterinary Hospitals or other similar institutions.

To create and work in conjunction of various projects with Governmental Authorities and/or with non-Governmental Organizations and/or such other funding agencies in India and/or abroad for the upliftment of the people in general and minorities and weaker sections of the society in particular within the territory of India.

To grant aid to underprivileged children and/or poor and indigent people for their maintenance and/or housing and/or education and/or for other objects of public utility.

To establish, maintain and grant aid to charitable institutions engaged in advancement of education and/or in the welfare and upliftment of people in pursuit of knowledge.

To grant aid to promote, establish, support, and/or maintain institutions and centers for the promotion of science and/or literature and/or medical technical and/or performing arts and/or arts and/or sports and/or any other extra-

research and developmental work for benefit of mankind.

To declare literary or scientific award for outstanding work and achievement.

To work and/or to donate. For alleviating poverty, medical relief and for the advancement of any other object of general public utility in compliance with the requirements of income Tax laws.

To undertake or assist in any other activity or project which the trustees may deem fit and which is conducive to the furtherance of the aforesaid object of the trust.

The trustees together shall constitute the Board of Trustees. The Trustees shall elect one of the trustees as the "Managing Trustee" for such period as the Trustees may decide, who shall take decisions in consultation with the Board of Trustees and shall function as the Chairman of the Trust.

All proceedings and question and matters arising at the meeting of the Trustees shall be decided by a majority of votes and in case of equality of votes the chairman of the Board of Trustees shall have a second or casting vote.

The Board of Trustees shall be responsible for the execution of the subject matter of the Trust.

The Board of Trustees by a resolution may authorize a person to exercise such powers as may be delegated by the Board of Trustees in the same manner as the Trustees could do for the particular purpose.

Nothing contained in this deed shall be deemed to authorize the trustees to do any act which may in any way be construed as statutory modification therefore and all activities of the trust shall be carried out with a view to giving benefit to the public without any profit motive and in accordance with the provision of the income

The trustees may accept any donation or contribution in cash or in kind, including any gift of movable and/or immovable property, from any person, firm, company, corporation, association, institutions or trust including the settler trustee for the furtherance of the object of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust, and all such donations, contributions and gifts shall form part of the trust property. The trustees may also take over the management of any other institutions on such terms as they think fit and manage such institutions.

The aims and objects for which the Trust has been constituted are to utilise the capital and income from the assets of the Trust without necessarily the contemplation of any profit as such, for assisting and promoting Islamic:- Religious, Social, Cultural, Spiritual and Educational Advancement of the Muslim Community including any individual Muslim or Group of Muslim persons or any Association, Institute or Organisation of the Muslim Community as the Trustees in their sole and absolute discretion may determine;

To establish and operate Mosques, Jamaat-Khanas, Cemeteries, Social Institutions and/or Educational Institutions for the benefit of the Muslim Community as the Trustees in their sole and absolute discretion may determine;

To fund and maintain existing Mosques, Jamaat-Khanas, Cemeteries, Social Institutions and/or Educational Institutions for the benefit of the Muslim Community as the Trustees in their sole and absolute discretion may determine..

Without affecting the generality of powers and functions of the

whether representing the corpus or income in such investment as the Trustees may deem fit and proper, with full liberty and power to invest and keep invested the same in purchase of approved securities or immovable properties, other assets and/or in bonds or government savings certificates and/or to invest in any share, stock or debenture of any government company and/or in any lone of the Central or State Government and/or deposit with any scheduled bank or mutual fund as required and specified under the provisions of the Income Tax Act and Rules

To open bank account or accounts with any nationalized bank or scheduled bank under the RBI and operate the same through Authorized Signatory (s) of the Board of Trustees.

To arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustees and to make the same effective and binding as if the same were signed by all the trustees.

To purchase acquire or lease out, let out, sell, transfer, mortgage, alienate and/or otherwise deal with any movable or immovable property that may be comprised in the trust, for carrying out the objects of the trust.

To appoint and/or make provisions for the appointment of subcommittee of trustees and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in subject to such rules and regulations as the trustees may prescribe.

To spend any portion of the corpus or the income the trust fund for purchasing any land and/or building of building and/or constructing any building or building for and in the name of the

he trustees shall maintain and/or cause to maintain true and accurate accounts to be kept of all monies received and spent and all of matters in respect thereof in course of management or trust properties or in relation to the carrying out of the objects and purposes of the trust as well as of all the assets, credits and effects of the trust properties. At the end of the financial year such accounts shall as soon as practicable be audited by a qualified chartered accountant and be placed before the Board of Trustees for their perusal and approval

In case of any vacancy to the Managing Trustee, due to resignation, death of incapability or otherwise the post may be filled up by any one of the Trustees by majority vote.

The trustees may invest the trust estate either in the purchase, or lease of immovable properties or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of and transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in sub section 3 of Section -13 of the Income Tax Act, 1961, or any subsequent amendments thereto.

If the income from the trust fund is not fully utilized in a year, the unexpended income subject to the applicable provisions of the Income Tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the object of the trust.

The trustees shall be at liberty to sell such portion or portions of the movable or immovable properties forming the trust properties (estate) either by public auction or by private contract at such price or prices and in such terms and conditions relating to title or otherwise in all respects as they may in their discretion think fit

the same and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharges for all monies received by them.

The trustees may pay all charges and outgoing payable in respect of any immovable property for the time being forming part of the trust fund and may carry out repairs required to be done to the same and keep the same insured against loss and damage and may incur all other costs, charges and expenses incidental to the administration and management of the trust estate and the properties for the time being belonging to the trust, as they may, in their absolute discretion think fit.

The Board of Trustees shall have the power to co-opt any persons as trustees so long the total number of Trustees does not exceed the maximum limit prescribed and to fill up any vacancy within the Board of Trustees on account of resignation, death, incapacity or otherwise. If however, the sole trustee dies or becomes incapable without making any appointment in terms of these persons capable of appointing a new trustee, then the nearest male lineal ascendant or the nearest male lineal descendants if there be any than one of the settlor. Failing such lineal descendants, the nearest heirs of the nearest heirs will be trustee/trustees.

The trustees may manage or supervise the management of any lands, and premises for the time being comprised in the trust estate or any part thereof with the power to erect, pull down, add to, alter and repair houses and other buildings and to build drains and make roads and fences and otherwise improve and develop and to cultivate or cause to be cultivated all or any of the said lands and premises and to insure the houses and buildings against loss or damage by fire and/or other risks or to let, lease, make allowances

deal with the said premises as they may deem fit in their absolute discretion.

The trustees may appoint Secretaries, Managers, Doctors, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, and such other employees as are necessary for the purpose of management and supervision of the Trust Estate and/or the Trust property, for collection of rents, effects and profits, for keeping the account and records and for other purposes of the trust, on such terms and salary or payment as the Board of Trustees may decide.

The trustees may establish any other office at such place or places as they think fit and may change the place of office if necessary.

The trustees may demise the immovable property or properties for the time being and from time to time belonging to the trust either for year to year on any fixed term or for any term of years or on monthly tenancies at such rent and subject to such covenants and condition as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.

The trustees have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and/or the Trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or Trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bona fide loss occasioned hereby.

The trustees may join, co-operate and amalgamate the trust created by these presents or any portion thereof with any trust or institution having allied or similar object upon such terms as they

The trustees may from time to time frame schemes and rules and regulations and bet-laws for the administration of the said trust and to carry out the objects of the trust and for the managing the affairs of the trust and otherwise for giving effect to the objects and purposes of the trust and to rescind, to or alter the same from time to time as the trustees may in their discretion deem fit and proper.

The receipts granted by the trustees and or any or more of them for any moneys stocks, funds, shares, securities or investments paid, delivered or transferred to them in exercise of the trust or power hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.

The trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and re-start any charity or charitable institution, to impose any condition or conditions to any subscriptions or donations made by them and to earmark any portion of the Trust property or income for any particular object or objects.

The trustees may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred by them in of about the execution of the trust or any of their duties under these presents including travel expenses, but will not be entitled to any remuneration and/of profit.

The trustees, in their discretion shall from time to time pay such sum of sums, of money to any or all of the beneficiaries out of the income and/or corpus of the trust and any such payment shall however be for the purposes, objects and uses of the trust.

All the trustees unless they voluntarily resign or otherwise decide, or become incapable of discharging their duties and obligations

term of their natural lives unless otherwise removed through application of law or in terms of the provisions hereof.

The number of trustees shall not be less than two and more than twelve.

Any trustee may retire at any time by giving one month's prior notice, without assigning any reason and without being responsible for any costs occasioned by such retirement.

The surviving or continuing trustees may notwithstanding any vacancy in their board act as trustees PROVIDED HOWEVER that if the number of trustees shall fall below two, the minimum fixed by these presents, the remaining trustees shall not, except for the purpose of filling any vacancy, act so long the number is below the said minimum.

The quorum for any meeting of the Trustees shall be 1/3rd of the number of trustees in position, subject to a minimum of 2.

All proceedings and question and matters arising at the meeting of the Trustees shall be decided by a majority of votes and in case of equality of votes, the Chairman of the board of Trustees shall have a casting vote.

In case of difference of opinion between the Trustees the opinion of the majority shall prevail and if the trustees are equally divided in any matter, the Chairman of the Board of Trustees shall have a casting vote.

A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees shall be as valid and effectual as if had been passed at a meeting of the trustees duly called and convened.

Notice of the meeting of the Trustees and all communication may be

The Board of Trustees may meet from time to time for transacting/regulating the activities and functioning of the trust.

The managing Trustee may at any time summon a meeting of the Board. Any such meeting shall be presided over by the Managing Trustee who shall arrange for proper maintenance of the minutes of the proceedings. In the absence of the Chairman, the meeting of the Board of Trustees shall be presided over by any trustee to be elected by the trustees in that meeting, who shall be competent to exercise the casting vote, if the situation so demands.

A trustee who is unable to be present at meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.

The Managing Trustees or any trustee shall provide for the safe custody of all funds, security and other valuables of the trust and of all papers and documents including the Books of Accounts and shall cause maintenance of proceedings of the meeting of the Board of Trustees recorded in proper books kept and maintained at the Trust Office.

The minutes of the proceeding of every meeting of the Trustees shall be entered in a book to be kept for that purposes and signed by the chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed by conclusive

A person shall cease to be a trustee on any of the following events:

If he dies; or

If he becomes bankrupt; or

If he becomes insane or otherwise becomes incapable to act; or  
If he resigns his office.

On a new or additional trustee being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment, the Trust Property shall automatically vest in him along with the other trustees for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other deed or writing.

The Board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.

If the trustees with a majority of 3/4th think that object of the trust cannot be effectuated as decided originally, they may decide to dissolve and transfer the assets and liabilities of the trust to a similar trust for continuance of the avowed object.

Trust may also accept any other trust(s) or institution(s) with similar objects who want to merge with it for continuance of its object as settled.

It shall be lawful for the trustees to make amendments in the trust deed for property effectuating the intent and purpose of these presents and in view of requirements of the law of the country from time to time. Any amendment to these presents shall however be made by at least 3/4th of the trustees existing at that point of time.

The Trustee or trustees shall frame and regulate their own procedure relating to the meeting of the Board of Trustees and

The Board of Trustees may, by a unanimous vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, from office, after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the Trust Estate or trust affairs and after arriving at definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee was desirable keeping to the object of the trust in view and other related or connected matter provided however that not conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his/her conduct and/or the charges leveled against him/her for this removal. The decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere.

The trust will never act like Micro financing and Money Laundering (Act 2012) Economic offence/crime in connection with sec 20 and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA Act from the Central Govt./ the competent Govt. authority which the trust and the trustees are responsible for and come under the all punishable law (CRPC and IPC).

All aims/objects/purpose of the trust herein stated above shall come into effect/force after necessary approval of the competent Govt. authority in the case where affiliation, permission/ lisencc/ sanction is required.

**LAWFUL PURPOSE -**

A trust may be created for any lawful purpose. The purpose of trust is lawful unless it is -

- (a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) if

property of another, or (e) the Court regards it as immoral or opposed to public policy. Every trust of which the purpose is unlawful is void. And where a trust is created for two purposes, of which one is other unlawful and the two purposes cannot be separated, the whole trust is void.

APPLICATION OF INCOME TAX- To perform that notwithstanding here in contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to the PUBLIC CHARITABLE TRUST PURPOSE ONLY within such territories and subject to such conditions or limitations if any as may from time to time be laid down by the Income Tax Act, 1961 Or Any Other Acts governing taxation of income the wealth of PUBLIC CHARITABLE TRUST so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or acts, now or prevailing or any modification replacement thereof.

To act in such a way that the TRUST hereby established shall always retain the status of one such TRUST no provisions of section 80G/12A/FCRA/35AC/10(23C) IV/V/VIA of the Income Tax Act, 1961 or any modification replacement or there of for the time being in force shall apply so that any donation or contribution there is recognized as eligible for exemption or relief from tax in the hands of the Donor.

APPOINTMENT OF NEW TRUSTEES it is agreed that if the Trustee see fit he may appoint an additional Trustee to be Trustee of the Trust. Change of trustees it is agreed that if the Trustee becomes unable or unwilling to act as Trustee of the

trustee to be Trustee of the Trust provided that this new trustee shall accept his appointment.

**DELEGATION OF POWER** The Trustee shall have the power to delegate the administration of the Trust to any third party which he in his absolute discretion responsible for the actions of any party to whom he has delegated authority.

Amendments to the Scheme : if any time it is found that alteration in any of the provision of the Trust or scheme for the purpose of effective achievement of the object of the Trust are imperative and very essential, then the Board shall approve such alteration by a resolution passed in its meeting and thereafter the modification shall become part and parcel of the terms, condition and provision of this Trust and this scheme.

The Board may at any time and from time to time make, amend, delete and rescind rule and bylaws for the conduct of this business, for the control management and administration of the Trust made under this Trust Deed and for carrying out the objects of the Trust relating to any matter under the scheme, provided that such rules and bylaws shall not be inconsistent with or repugnant to any provisions of the scheme of the Trust.

Present the Trust has no moveable immoveable and landed property in it's own name and no immoveable and landed property is settled in favour of this trust by this documents and no moveable property is involved in this trust deed.

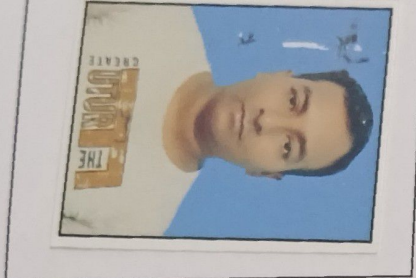

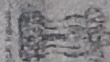
